Land Acknowledgement

Tamarack Recovery Centre is on Treaty 1 Territory, the traditional home of the Anishinaabe and homeland of the Métis Nation.

For thousands of years, Indigenous people, including the Cree, Dene, Assiniboine, Oji-Cree, and Dakota, have used "Where the Rivers Meet"—now known as The Forks in Winnipeg—to gather, trade, celebrate, coexist, and develop relationships with others.

It is in this spirit of cooperation and in recognition of this history, including harms caused by colonialism, that Tamarack endeavours to uphold the Truth and Reconciliation Commission's Calls to Action as we seek to help people recover from drug and alcohol dependency.



ABOUT TAMARACK

TAMARACK RECOVERY CENTRE is a nonprofit, 12-bed, all-gender recovery treatment centre providing addiction treatment and recovery services in Winnipeg. Tamarack also operates The Branch, a second-stage treatment option and sober living space for program graduates looking to extend their recovery in safe, affordable shared housing.

Since incorporating in 1975, Tamarack has provided thousands of Manitobans with flexible, participant-driven, community-based treatment and support. Our highly accredited programming is rooted in recognized best practices and evidence-based treatment to support individuals who seek to recover from addictions. We take a trauma-informed approach to ensure that participants who have experienced trauma and/or mental health challenges receive the most appropriate care. Our programming balances structure with flexibility, providing community-based treatment that works.

Tamarack's model is built on 50 years of experience, learning and continuous feedback from our community. Over time, our program has evolved from an initial single-service model to one that now offers a holistic approach to recovery, incorporating a range of evidence-based and traumainformed services that are responsive to participant needs and the shifting landscape of addictions in our city.





The Tamarack Difference

SAFE, INCLUSIVE ENVIRONMENT: We commit to creating a safe(r) space for everyone. We want all participants, visitors, and staff to feel welcome here, no matter their religious beliefs, culture, race, gender, or sexual orientation. We value compassion and respect, and strive to create a family-like atmosphere where everyone feels accepted, supported, and free to express who they are.

MORE TIME, GREATER ACCESS: We offer a 60- to 78-day residential treatment program for individuals wishing to achieve sobriety from substance addictions, such as alcohol and drugs, as well as behavioural addictions such as gambling. Our unique longer-term program provides support for participants to begin healing from trauma, while building recovery and living skills using evidence-based approaches to treatment. We offer a low-cost fee structure and a Participant Subsidy Fund buoyed by philanthropy to ensure no one is turned away for lack of funds.

SEAMLESS POST-TREATMENT SUPPORT:

All treatment graduates have access to free, unlimited aftercare support through a dedicated program that focuses on lifestyle management to support long-term recovery—a unique offering that sets Tamarack apart from other programs. Tamarack's new transitional housing program, The Branch, expands these supports with a next-step option for graduates who wish to develop greater independence and grow in recovery while continuing to live in safe, supervised sober housing.

DEMONSTRATED IMPACT: Tamarack's services are life-changing—and potentially life-saving—for Manitobans experiencing addictions. Many of our participants sustain long-term recovery from their addiction and go on to become strong contributing members of society: since 2013, the Centre has an average completion rate of 83%, far exceeding the industry average of 44% for longterm residential addictions treatment, and graduates of Tamarack report post-treatment sobriety rates well above national norms.

6 | TAMARACK RECOVERY CENTRE

OUR COMPREHENSIVE WRAP AROUND PROGRAM GOES FROM STRENGTH TO STRENGTH.



Tamarack's unique program offers a continuum of care that starts even before a person begins treatment and continues in perpetuity to support sustained recovery. This comprehensive approach enables Tamarack to meet each participant where they are and remove the burden of navigating complex systems and services so participants can focus on their recovery. The program includes four phases of care, pre-treatment, residential treatment, extended treatment and housing support and aftercare.

2024-25 was an impactful year for Tamarack's programs with increases in participant numbers, hours of support and graduation rates.

"The intake could not have gone better...and [the intake counsellor] was the reason I felt comfortable and made the decision to come into Tamarack over the other programs that I had looked at. It was warm and welcoming from start to finish."



Program Summary and 2024-25 Highlights

PRETREATMENT PROGRAM

Tamarack's specialized pretreatment program, provided free of charge, works to meet the individual needs of each prospective participant when they seek treatment support. Using an in-house toolbox of evidence-based methods, resources, and strategies, our Intake Coordinator offers a level of engagement, personal connection, and accountability that ensures a safe and supportive transition into treatment at Tamarack and/or access to the most suitable (or immediately available) support for prospective participant needs..

Of the applicants, 285 met treatment criteria for in-patient treatment and were able to access the first stage of the Pre-Treatment Program. Throughout the stages of the pre-treatment program, individuals were supported in accessing community resources, detox services and additional medical supports.

On-site testing at tamarack was provided alongside regular check-ins and recovery workbook provision. Of those 285 individuals supported through pretreatment, 67 entered Tamarack's treatment program with the average number of days of Pre-Treatment Program support provided amounting to 35 days or 5 weeks per person.




RESIDENTIAL TREATMENT

Tamarack has created a holistic approach to recovery, supporting participants' mental, physical, and emotional healing. Through our 12-bed residential treatment centre at 60 Balmoral Street, we offer a unique longer-term program (60 to 78 days) to give participants the time, space, and guidance to recognize and understand the issues that have led to addiction, while learning and

practicing new life skills that can aid longterm recovery. Through workshops, individual counselling, and group therapy, Tamarack introduces practical tools, skills, and insights that can empower individuals to begin to work on unresolved issues, rebuild relationships, and connect with healthy supports that help maintain long-term recovery.

Tamarack serves participants aged 18+ who identify as having an addiction to one or more substances. Among our 2024-25 participants:



Our participant completion rate for 2024-25 was 83%, a further increase on the last two year's completion rates and well-above an average of 44% among other long-term residential addictions treatment programs.

EXTENDED TREATMENT & TRANSITIONAL HOUSING SUPPORT

To address participant needs for continued recovery services and safe, affordable housing after graduation, Tamarack created The Branch, an optional extension of treatment services that includes an affordable housing program and tailored transitional supports that give graduates the confidence and tools to reintegrate back into work, school, and family life.

With one-on-one support from counsellors, each resident creates an individual transitional program plan that guides them towards increased independence. The Branch houses

This year The Branch experienced greater demand than last year, providing 22 people with extended care and supportive housing.

The average age of residents was 40 years old with 7 male-identifying and 15 femaleidentifying. The average length of stay was 7 months.

up to 10 residents at a time, allowing tenants up to two years in this warm, welcoming environment. The house is centrally located, at 54 Balmoral Street, two doors down from Tamarack's treatment facility.

Survey results from participants living at The Branch illustrate how essential this program has been to their recovery during this vulnerable early period. 86% of respondents said that they did not believe they would be sober or were not sure they'd be sober today if they didn't have The Branch:

"I have a strong commitment to overcoming addiction and improving my mental health and living... The Branch has supported my progress."

"I'd probably be back in jail by now."

"I feel that I would likely still be sober but with a much lower quality of life and certainly would not be getting the opportunities and support like I have been at the Branch."

Speaking more about the wrap-around extended care and recovery support, residents shared:

"I'm incredibly grateful for Tamarack and The Branch. I am fortunate to live with such a great group of people, including staff, who feel like a family to me. I am nine months sober... and I really believe life will only get better from here."

"You have given me an opportunity to change my life. It means the world to me."





AFTERCARE

Recovery is an ongoing journey that doesn't end after treatment is complete and we've seen firsthand that the longer individuals stay sober, the more likely it is that they will be able to return to work, be with their children and families, and live well. That's why we offer free, unlimited aftercare services to all program graduates for as long as they need it. Our aftercare program is tailored to individual needs and focuses on counselling and lifestyle management to support longterm recovery, while fostering a supportive community among graduates. We extend that support to graduates' families and loved ones, as research and our experience has shown that recovery is most successful when those closely connected to a person in treatment also receive support themselves.

"I enjoy aftercare, it's a time to engage, listen to others and share my experiences. [the aftercare counsellor] is kind, patient, nonjudgmental, professional, down to earth and goes out of her way to help people with resources if she can! I'm really lucky to have the opportunity to work with her".

This year Tamarack provided an outstanding 1,473 hours of aftercare services to our graduates, a 50% increase on last year's numbers. This year 85% of aftercare survey respondents reported that they continue to return for counselling with a Tamarack counsellor; 100% of aftercare survey respondents attend our aftercare group offered to all graduates and taking place twice weekly at The Branch.







Increasing Access and Building Safe(r) Spaces

BUILDING FINANCIAL SUSTAINABILITY AND INCREASING ACCESS THROUGH THE PARTICIPANT SUBSIDY FUND

Over the past half-century, Tamarack has demonstrated the power of a holistic, participant-centered program that prioritizes depth of care. Our time-tested approach is what makes Tamarack uniquely successful, and we are dedicated to sustaining a gold-standard level of care with meaningful results.

Our path ahead is not without its challenges. Financial need is a significant barrier to accessing addictions treatment in Winnipeg. The majority of our participants do not have the means to self-fund their treatment and many also lack other forms of financial support, such as coverage through employee assistance or insurance plans.

In the face of this challenge, and recognizing the acute need for accessible, high-impact addictions treatment in Winnipeg, Tamarack, with the support of a multi-year funding commitment from The Moffat Family Fund at The Winnipeg Foundation and donations from supporters, established a Participant Subsidy Fund in 2020. This fund helps facilitate access to treatment spaces for individuals who may not otherwise be able to afford addictions treatment. Ongoing donations and continuing support from the Moffatt Family Fund at The

Winnipeg Foundation, as well as the Bruce Oake Foundation and private donors, have allowed us to offer this vital and responsive program for a further year.

This year 19 participants were supported by the Participant Subsidy Fund, either through full fee support or supplementing the funding they were able to provide. Having the level of flexibility to provide funded places in full or in part has empowered our participants to determine what they can contribute to their treatment, if anything, and to feel confident asking for and receiving support.

"I am feeling content, capable, resilient and assured. Had the funders not been agreeable to financially assisting me on this path, I do not think I would have attained a similar level of recovery. Words seem a slight acknowledgement in relation to the gift that has been given me...I have been given my life back, and I will be forever grateful. I was not expecting the kindness, understanding and generosity given to me...Had it not been for this [funding], I would not have had the means to have participated in this program".





In order to sustain our Fund, we must raise \$200,000 annually to ensure that Tamarack's life-changing wraparound treatment and recovery support is available to everyone who needs it.

This year we worked to evolve our funding model to garner increased investment from other sources so we can continue to operate our high-quality, comprehensive treatment program without compromise, while ensuring access to participants.

A grant from the Government of Canada's Community Services Recovery Fund allowed us to develop and launch this new funding model with strategies and tools for engaging partners in philanthropy, the private sector, and all levels of government. The model is designed to support the diversification of funding sources and build a strong and sustainable

financial direction for Tamarack so we can continue to operate our programming without compromise, while ensuring equitable access for participants.

This year, this work has enabled us to build our first-ever case for support for use in funding proposals and launch a new website. We have also established a suite of internal tools, systems and practices for the smooth management of fundraising operations.

A particularly positive outcome of this work has been the new relationships forged with Winnipeg's philanthropic community. This project has already had a significant impact on our organization – and we expect this to grow as we implement plans to leverage Tamarack's 50th anniversary year in 2025 to deepen our donor base.



INCREASING ACCESS THROUGH THE CREATION OF SAFE(R) SPACES

At Tamarack, we take pride in living our values of safety, integrity, respect, excellence, and compassion. We are driven by a commitment to equity and widening access for people seeking addictions treatment and create an inclusive and culturally responsive program that is tailored to the diversity of our community.

Indigenous Programming: Through governance processes, staffing, and programming, we acknowledge Canada's history of engagement with the First Peoples and work towards reconciliation and collaboration in how we meet participants' needs. Tamarack strives to integrate Indigenous healing practices, knowledge sharing, and community engagement into our programs through volunteerism and workshops. This year, we have connected with Indigenous community members to establish how best to offer or

provide access to a range of Indigenous-led and culturally supportive programming for our staff and participants.

Inclusive Care: Traditionally, treatment offerings in Manitoba operate programs according to the male-female binary and are not fully inclusive of the 2SLGBTQI+ community. Tamarack is the only treatment centre in Winnipeg that welcomes all genders, providing such offerings as dedicated private bedroom spaces to ensure a person's identity is not a barrier to treatment. We are also actively engaged in a variety of anti-oppression trainings and other Diversity, Equity and Inclusion learning opportunities to support a sense of safety and belonging for everyone in our community, from participants and graduates to staff and board members.





Interior Improvements - While the 100-yearold building that is home to Tamarack's addictions treatment centre is central to our community-based model, it also brings space and layout constraints that are having a significant impact on our ability to deliver an accessible, inclusive, and supportive treatment experience. Informed in large part by the desire to be able to offer greater access and a sense of safety to members of the 2SLGBTQIA+ community, along with the need to ensure efficient and timely access to treatment, we made the decision to repair and evolve an underused area of the home into offices and a fitness space, allowing us to use the newly vacant rooms for participant accommodation.

In the fall of 2024, the repair and renovation work began and as we wrap up this fiscal year (March 2025), we are nearing completion of the fitness and yoga area along with three new

offices for Tamarack staff, freeing up space for new private bedrooms. Offering in-house opportunities for boosting physical and mental health to participants through the creation of these spaces will be an important and positive addition to our holistic program.

Our community of funders and supporters have helped make this project a reality and we are deeply grateful for the support from Canada Life; The Winnipeg Foundation; Princess Auto Foundation; Access Credit Union, BIL Security and Youth in Philanthropy at The Winnipeg Foundation. These generous funders have helped support a very "Tamarack" project – participant driven, with a focus on finding creative solutions to challenges and building a community of support to achieve something lasting and impactful.



MAINTAINING EXEMPLARY STANDARDS THROUGH CONTINUOUS EVALUATION AND GROWTH

Tamarack's quality of care benefits from robust internal evaluation practices as well as external accreditation, ensuring accountability to participants and their loved ones as well as to our staff, stakeholders, and community. Tamarack is proud to be a learning-oriented organization, working at the intersection of evidence-based, experience-backed practices and participant-centered responsiveness. We collect extensive data and feedback, from participants, families, staff, and our Board, while keeping abreast of emerging needs in the addictions landscape, to understand program strengths and identify opportunities for improvement and enhancement.

Tamarack has demonstrated its commitment to the highest standards of care with accreditation from Accreditation Canada, a nonprofit, independent organization accredited by the International Society for Quality in Health Care. Since our first accreditation in 2014, Tamarack has retained Exemplary Standing, the highest level of performance that can be attained in the Accreditation Canada program, demonstrating

excellence in line with criteria such as accessibility, safety, client-centered services, continuity of care, and efficiency. Tamarack's most recent accreditation report affirmed that "Quality improvement is embedded into the culture of the organization."

Tamarack is also fully accredited by Imagine Canada, demonstrating organizational excellence in five areas of operation: board governance, financial accountability and transparency, fundraising, staff management, and volunteer involvement. This recognition is a testament to our rigorous financial management and accountability to our board, funders, stakeholders, and community.

Tamarack continually monitors a wide range of quality indicators to ensure we continue to meet and exceed the high standards we have set for safety, participant wellbeing, and staff support. From this data and feedback, we make real-time improvements to our programming and staff support as well as build upon the successes within the program.



INDEPENDENT AUDITOR'S REPORT

To the Members of TAMARACK REHAB INC.T/A TAMARACK RECOVERY CENTRE

Opinion

We have audited the financial statements of TAMARACK REHAB INC.T/A TAMARACK RECOVERY CENTRE (the "organization"), which comprise the statement of financial position as at March 31, 2025, and the statements of revenues and expenses, changes in net assets and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the organization as at March 31, 2025, and the results of its operations and cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO).

Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. - Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the organization's internal control.

Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the organization to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

DESCRIPTION OF OPERATIONS

Tamarack Recovery Centre operates two residential treatment facilities for individuals with chemical and alcohol dependencies and other drug abuse problems, which facilitates independent living and lifestyle change. Tamarack Recovery Centre is incorporated under the Manitoba Corporations Act as a non-profit organization and is a registered charity under the Income Tax Act (Canada).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO).

Revenue recognition

TAMARACK REHAB INC.T/A TAMARACK RECOVERY CENTRE follows the deferral method of accounting for contributions.

Restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured. Endowment contributions are recognized as direct increases in net assets.

Restricted investment income is recognized as revenue in the year in which the related expenses are incurred. Unrestricted investment income is recognized as revenue when earned.

Seminar fees are recognized as revenue when the seminars are held.

Measurement uncertainty

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Such estimates are periodically reviewed and any adjustments necessary are reported in earnings in the period in which they become known. Actual results could differ from these estimates.

Capital assets

Tangible capital assets are stated at cost less accumulated amortization. Tangible capital assets are amortized over their estimated useful lives at the following rates and methods:
